Contest Rules and Regulations Organiser and Eligibility

1. The PERADUAN NESTLE ONG ["Contest"] is organised by Nestlé Products Sdn. Bhd. [45229-H] ["the Organiser"] and is open to all legal residents of Malaysia aged 18 years and above as of 12/12/2016 [each a "Participant" and collectively, the "Participants"]. The Organiser reserves the right to request for identification document as proof and for purposes of verifying the identity of a Participant.
2. The following persons are not eligible to participate in the Contest:
[a] Employees of the Organiser (including its affiliated and related companies) and their immediate family members [spouse, children, parents, siblings (and their spouses)]; and/or
[b] Representatives, employees, servants and/or agents of advertising and/or promotion service providers of the Organiser (including their affiliated and related companies), and their immediate family members (spouse, children, parents, siblings (and their spouses)).
3. The Organiser shall reserve the right to exclude and/or disqualify Participants who do not fall within the category of Participants and/or who are in breach of the Contest Rules and Regulations.

Duration

1. The Contest will run from 12/12/2016 to 05/02/2017 ["the Contest Period"]. The Organiser shall reserve the right at its absolute discretion to vary, postpone, re-schedule and/or extend the Contest Period and/or cancel/terminate the Contest at any time without prior notice. All entries received outside the Contest Period will be automatically disqualified.

Qualifying Criteria and Submission of Entries

1. For every purchase of any participating NESTLÉ Ready To Drink products with an expiry date in 2017 and beyond during the Contest Period will entitle the Participant to enter the Contest. Please refer to the Proof of Purchase Table ["POP Table"] for the product packaging required as the proof of purchase to participate in the Contest ["POP"].
2. Participants are required to complete each entry form with the required details, and correctly answer three (3) True or False questions shown in the entry form. The completed entry form together with the POP must be inserted in an envelope and posted by ordinary mail to the PO Box address stated in the entry form. The Organiser will not be responsible for any non-receipt of postal deliveries due to insufficient postage or incorrect address. Entries received via dispatch, courier service, POS Laju and/or any other means of delivery will be automatically disqualified. Proof of postage of an entry form shall not constitute proof of receipt by the Organiser.

All entry forms received by the Organiser during the Contest Period that are complete with the required details, POP and correct answers, if approved by the Organiser, will be serialised according to POP Table based on the POP submitted [each a "Qualified Entry" and collectively the "Qualified Entries"].

Prizes

1. The Prizes for the Contest are divided into two (2) tiers.
2. **Tier 1 – Daily Prizes:**
There are five (5) Daily Prizes for fifty six (56) consecutive days. There is a total of two hundred and eighty (280) Daily Prizes to be won throughout the Contest Period.
3. The serial numbers allocated to each day's Qualified Entries will be tabulated to derive the total serial number which will then be divided by five (5) to derive the winning serial number for each day's Daily Prize. In the event of numbers with decimal values, the winning serial numbers will be rounded down to the nearest whole number that results after the division.
For example:
If the day's Qualified Entries serial numbers total up to 887, 887 will be divided by 5 which equals 177.4 which will be rounded down to 177. The multiplier number in this case is 177. In the event of numbers with decimal values, the winning serial numbers will be rounded down to the nearest whole number that results after the division.

If the two (2) weeks Qualified Entries serial numbers total up to 21689, 21689 will be divided by 2 which equals 10844.5 which will be rounded down to 10844. The Participant of the two (2) weeks assigned with 10844 will be the Winner of the two (2) weeks Grand Prize.
For example in Week 7 & 8:
If the two (2) weeks Qualified Entries serial numbers total up to 21689, 21689 will be divided by 2 which equals 10844.5 which will be rounded down to 10844. The multiplier number in this case is 10844. Two (2) Participants of the two (2) weeks assigned with 10844 and 21688 will be the Winners of the two (2) weeks Grand Prizes.
8. The Grand Prize winners selected will each win a metallic PERODUA BEZZA 1.3 PREMIUM X [Automatic Transmission] on-the-road worth Ringgit Malaysia Forty four thousand eight hundred [RM44,800]. Price shown is based on Peninsular Malaysia pricing and is correct at the time of printing.
